
Britain: Power and the People

1. Study source A. How useful is source A to a historian studying.....

(8 marks)

- How reliable is the source according to the provenance? Use who created the source, the type of source it is, the date of publication and the purpose of the source

- Can you answer the question from different peoples' perspective?
- Use your knowledge of the world today and don't be afraid to include information from the news in 'influence today' section

- Try to organise your answer into three sections if possible

- You have got to make sure that the points that you make are events in the correct time period
- Always start with the factor in the question. Think of events in the time period that have been affected by that factor
- Consider all of the other factors that could be used to argue against the question. You only need to use 2 or 3

2. Explain what was important/significant about (8 marks)

- You are not writing everything you know, but selecting what is important
- Select three reasons, describe them clearly with detail, then show why they were effective/important/significant
- Show the consequences of the event to highlight significance

3. Write an account of

(8 marks)

- Chronological narrative
- Don't just tell a story – answer the question – link each point to the question
- Make three separate points

4. “Quote about the type of environmental site that you have been asked to study”

How far does a study of **environmental site** support this statement?

(16 marks)

- To support their answer candidates **could** include aspects of the site such as:
- location, function, structure, design, people connected with the site, how the site reflects culture, values and fashions of the time and how the site links to important events and/or developments of the specified period.
- Clear paragraph(s) that support the statement
- Paragraph(s) that disagree with the statement but still maintain a focus on the environmental site
- Conclusion that directly answers the questions set, it could partially agree and disagree and should try to see change over time
